Description

You are invited to participate in a research study that is a part of the Doctor of Business Administration (DBAR) program through the University of Southern Queensland. This study explores the impact of Women on board (WOB) on corporate social responsibilities (CSR) initiatives and the financial performance of the companies. This project will allow a greater understanding of the role of gender diversity on corporate boards to assist women seeking a role in this area. Policymakers can use the results of this study to plan future directions to assign board quotas for women directors and the companies can manage the succession planning for their board members. In addition, educational institutions can incorporate appropriate leadership training in their programs to prepare future leaders.

Participation

The survey will take a minimum of 15 minutes to complete. Your participation will involve completing an online survey consisting of 61 questions regarding the company where you work part-time or full-time as a member of the board. The questions will broadly cover four parts, i.e., the company's name, your leadership style, firm's financial and non-financial performance, and your demographic information (optional).

Your participation in this project is entirely voluntary. If you decide to take part and later change your mind, you are free to withdraw from the project at any stage. You may also request that any data collected about you be removed and confidentially destroyed.

Expected benefits

Information collected will be solely used for doctoral and scientific research purposes therefore, it is anticipated that the results of this research project will be published as a thesis for the doctoral study and presented in a variety of forums. In any publication and presentation, information will be provided in such a way that you cannot be identified. The outcome of the research will be available to you if requested.
